This test is open to all Poodles. Poodle Club of America rules will be used. WC/WCX Rules and Guidelines are available online at poodleclubofamerica.org. The Test will commence at 8:00 AM. Running order will be posted at the site.

Birds: Fresh killed ducks will be used for all tests.

Prizes: Each qualifying dog will receive a rosette ribbon. Qualifying WC and WCX Poodles are eligible for Poodle Club of America certificates.

Bitches in Season and injured dogs: In heat bitches can not run and are not allowed on the grounds. A full refund of \$40 will be available for bitches in season or injured dogs.

Test Headquarters: 1150 Highway 205 South Rockwall, TX 75032

Directions from I-30: Take Highway 205 South and travel approximately three to five miles. There is a nursery on the right and the driveway to the property is on the left. There will be a sign posted at the driveway of the property. We will have a parking area marked off so please park inside the designated area – as a courtesy to landowners

NO PARKING OUTSIDE THE GATES WHATSOEVER!

Food: Sandwiches and drinks will be available for a small donation.

Guidelines: There is some shade available but not necessarily near the test location.

- Please bring your own shade and water.
- Dogs must be on leash or confined when not running in test.
- Pinch, prong, and electronic collars are not allowed on the grounds.
- Please air/exercise your dogs away from the test location and those areas where there is likely to be foot traffic.

PICK UP after your dog. This is privately owned property. We must leave this facility in exceptional condition.

For spectators, a Marshall will be available to answer any questions regarding the tests and appropriate gallery etiquette. Please place chairs for viewing only in the area as instructed by the Marshall.

No loose dogs please. This event is for dogs entered in the WC, WCX, and the Novice Hunter Stakes.
